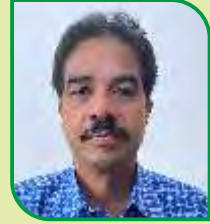

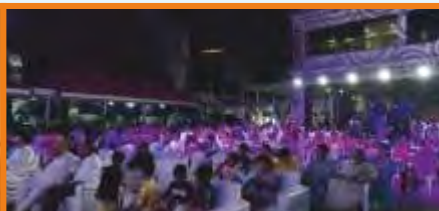

INVITATION TO THE YOUTH-MEMBERS FOR YOUTH FESTIVAL TO BE HELD ON

CULTURAL PROGRAMMES PROPOSED DURING DECEMBER, 2024:

It is proposed to celebrate-

- (I) CHRISTMAS EVE ON 24TH December, 2024 along with organising of “Youth Festival” for the youth of the FNCC on the Christmas Eve, i.e. on 24.12.2024.
- (ii) Celebration of “30 Years of FNCC” during last week of December, 2024 with Celebrities and eminent Personalities.
- (iii) For the entertainment of FNCC members, the prestigious “FNCC 13th ALL INDIA OPEN BRIDGE TOURNAMENT” will held on 1st, 2nd and 3rd February, wherein players of Bridge game from all over the country will participate.

MEMBERSHIP FEE OF “PERMANENT MEMBER” Category:

As per the approval of the Mgt. Committee in its meeting held on 25th October, 2024, the membership fee of “Permanent Member” has been reduced from the existing rate of Rs.29.0 Lakhs (including GST) to Rs.25.0 Lakhs (including GST) w.e.f. 1.10.2024.

Reduction in the admission fee for membership in “SENIOR CITIZEN” category:

The Mgt. Committee in its meeting held on 29.11.2024 has unanimously resolved to reduce the existing admission fee for giving membership in “SENIOR CITIZEN” category, from Rs.7.5 Lakhs to Rs.5.0Lakhs inclusive of GST. Accordingly, the revised rate will be implemented w.e.f. 1st December, 2024.

Reduction in the rate of interest on the dues of Members:

As per the Resolution of the Mgt. Committee in its meeting held on 29th November, 2024, the rate of interest payable by members on their outstanding dues shall be reduced from the present 24% to 10% with effect from 1st November, 2024

Extension of Gym Timing for Lady Members in the Morning Session:

On the recommendations of the Gym Sports Sub-Committee and approval of the Mgt. Committee thereon in its meeting held on 29th Nov. 2024, the Gym timings for Lady Members in the morning session have been extended from 12.00 Noon to 01.00 P.M. There is no change in the Gym timings of the Male Members.

Donations Called for - from Members of the FNCC for construction of 4 new Suit Rooms in the FNCC's Old Snooker Hall area:

As per the decision of the Mgt. Committee in its meeting held on 29th Nov. 2024, 4 new Suit Rooms will be constructed in the existing Old Snookers Hall and for this purpose, as per the Committee's resolution, donations @ Rs.15.0 Lakhs per Suit room have been called for from willing Members of the FNCC, for which the donor's Name will be displayed at the entrance of the Suit Room and the Donor will be permitted to avail the Suit facility for 30 days in a year.

REMUNERATION DUE TO THE OUTGOING MEMBER UNDER “TRANSFER OF MEMBERSHIP SCHEME”:

As per the approval of the Mgt. Committee in its meeting held on 25th October, 2024, out of the amount Rs.15.0 Lkhs including GST payable by the new Member under “Transfer of Membership Scheme”, Rs.10.0 Lakhs is payable to the outgoing Member of the FNCC under “Transfer of Membership Scheme” and the balance amount, excluding GST shall be towards building fund of the FNCC.

REPAIRS & RENOVATIONS PROPOSED & UNDER PROGRESS:

As per the approval of the Mgt. Committee, the following works will be taken up:

1. Renovation of Suit Rooms.
2. Exit Gate widening.
3. Conversion of Space behind “Mega-Star Dr. K.Chiranjeevi Sports Center“ as Players' Lounge.
4. Laying of Glass Canopy Roof over the vacant area beside Roof-top Chinese Restaurant.
5. To erect Retaining Wall by the side of Coffee-shop facing Temple-side Road.

CONTRIBUTION TO MEMBERS' WELFARE SCHEME AT ENHANCED RATE OF
RS.450/- p.m. UNWILLINGNESS, IF ANY, OF THE MEMBERS IN THIS REGARD - CALLED FOR

As per the approval of the AGM held on 29th September, 2024, it is proposed to enhance the rate of Monetary Benefit amount payable under Members' Welfare Scheme from Rs.6.0 Lakhs to Rs.10.0 Lakhs and for this purpose, the AGM has accorded approval among others to enhance the existing rate of contribution to the Members' Welfare Scheme from Rs.300/- p.m., to Rs.450/- p.m. To take necessary follow up action on the said approval of the AGM, the Mgt. Committee has unanimously resolved to call for the unwillingness, if any, of the Members, who are presently contributing to the Members' Welfare Scheme @ Rs.300/- p.m., for contributing towards Members' Welfare Scheme at the proposed higher rate of Rs.450/- p.m., w.e.f. 1.10.2024. As per the resolution of the Mgt. Committee if any member is unwilling for contributing at the said enhanced rate, but continue to contribute @ Rs.300/- p.m., they will be entitled to Rs.6.0 Lakhs only under the Scheme. FNCC Office has sent letter of communication, dt.1.11.2024, in this regard to the Members concerned requesting them to communicate their unwillingness if any to contribute to the said Scheme at the said higher rate, in the reply paid Inland Letter, copy of which is furnished hereunder for favour of information of the Members.
