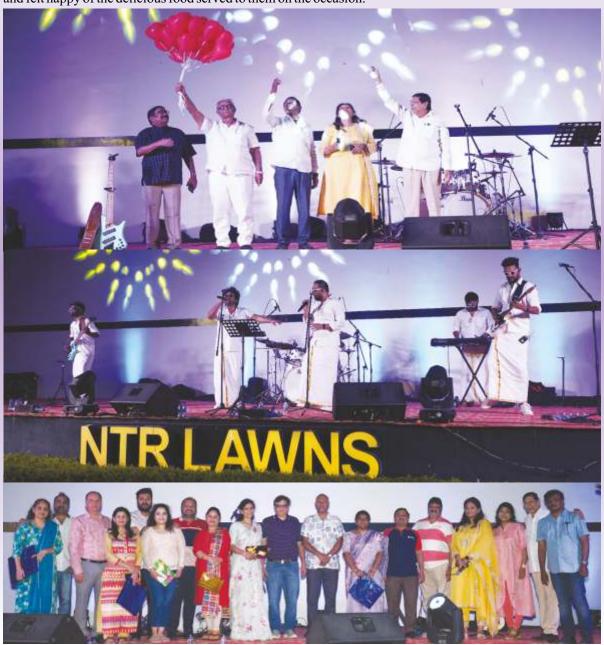

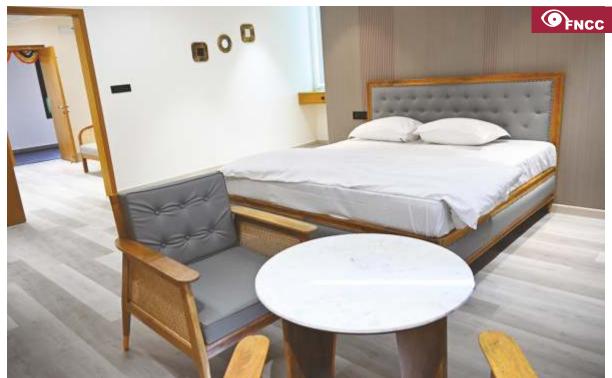

మీర్జాపురం రాణి **ర్రేమతి కృష్ణవేణి**

తెలుగు సినిమా రంగంలో (శీమతి కృష్ణవేణి గారిది ఓ సువర్ణ అధ్యాయం. నటిగా, నిర్మాతగా, నేపథ్య గాయనిగా, స్టూడియో అధినేతగా బహుముఖాలుగా ఎదిగి ఒదిగిన చిరస్మరణీయురాలు.

1924 డిసెంబర్ 24న పశ్చిమ గోదావరి జిల్లా పంగిడి గ్రామంలో డాక్టర్ యర్రంశెట్టి లక్ష్మణరావు, (శ్రీమతి నాగ రాజమ్మ దంపతులకు జన్మించారు. 1936లో దర్శకుడు చిత్తజల్లు పుల్లయ్య 'సతి అనసూయ' సినిమాలో బాలనటిగా ఆమెను పరిచయం చేశారు. 1939లో ఆమె మద్రాసులో స్థిరపడ్డారు.

అదే సంవత్సరం మీర్జాపురం రాజా మేకా వెంకటరామయ్య అప్పారావు బహదూర్ గారితో ఆమె వివాహం జరిగింది.

1949లో అక్కినేని నాగేశ్వరరావు గారితో 'కీలు గుర్రం' అనే సినిమాను నిర్మించిన కృష్ణవేణి అదే సంవత్సరం 'మనదేశం' సినిమాలో నందమూరి తారక రామారావు గారిని సినిమా రంగానికి పరిచయం చేశారు. అలాగే పల్లెటూరి పిల్ల సినిమాలో ఎస్.వి.రంగారావుకు అవకాశం ఇచ్చారు. 'మనదేశం' సినిమాలో ఘంటసాల వెంకటేశ్వరరావును సంగీత దర్శకుడిగా... తరువాత పి. సుశీల, జిక్కిలను గాయనీమణులుగా బ్రోత్సహించారు.

1947 అక్టోబర్ 24న ఈ దంపతులకు అనురాధ జన్మించారు. అనంతర కాలంలో ఆమె అక్కినేని నాగేశ్వరరావు, కన్నడ రాజకుమార్, శోభన్ బాబు, వడ్డే నవీన్, జె.డి. చక్రవర్తితో సినిమాలు నిర్మించారు.

1936 నుంచి 1951 మధ్యలో కృష్ణవేణి గారు సతీ అనసూయ, మోహినీ రుక్మాంగద, కచ దేవయాని, మళ్ళీ పెళ్ళి, మహానంద, జీవన జ్యోతి, దక్షయజ్ఞం, భక్త డ్రపహ్లోద, భీష్మ, డ్రహ్మరథం, గొల్లభామ, మదాలస, కామవల్లి (తమిళం), మనదేశం, ధర్మాంగద, లక్ష్మమ్మ, ఆహుతి, తిరుగుబాటు, పేరంటాలు చిత్రాల్లో నటించారు.

ఆ తరువాత శోభనాచల స్టూడియోస్ వ్యవహారాలను చూడటానికే పరిమితమయ్యారు.

కృష్ణవేణి సేవలను గుర్తించిన ఆంధ్రప్రదేశ్ ప్రభుత్వం 2004లో ప్రతిష్ఠాత్మక రఘుపతి వెంకయ్య అవార్దుతో సత్కరించింది. ఎన్.టి.ఆర్. శతజయంతి సందర్భంగా ఎన్.టి.ఆర్. లిటరేచర్ కమిటీ 2024లో కృష్ణవేణిని ఘనంగా సత్కరించింది.

్రశీమతి కృష్ణవేణి పరిపూర్ణ జీవితం గడిపి ఫిబ్రవరి 16, 2025న తన 101వ సంవత్సరంలో ఇహలోక యాత్ర ముగించారు.
